EIGHTH EMERGENCY ORDER EXTENSION and AMENDMENTS – EXPANDING MAGISTERIAL DISTRICT COURT OPERATIONS

AND NOW, this 17th day of June, 2021, this court having previously declared in the thirty-second (32nd) judicial district (Delaware County) a judicial emergency and that immediate past, emergent declaration extension pursuant to such an order of the Pennsylvania Supreme Court sanctioning the same yet remaining in effect,² as well as Pa.R.J.A. No. 1952(B)(1)(2), and this court thus still having those authorities detailed under Pa.R.J.A. No. 1952(B)(2)(a-s), it is hereby **ORDERED** and **DECREED** in consultation with the Magisterial District Court Administrator that the attached operational and/or scheduling protocols reflecting the local courts' transition to post-pandemic business processes **SHALL** become **EFFECTIVE** as is further detailed below.

For ALL otherwise appropriate lodgings, excepting then private criminal complaints, filed with the Delaware County (thirty-second (32nd) judicial district) magisterial district courts and/or ANY local court transactions, EVERY magisterial district court facility within this judicial district (32nd – Delaware County) SHALL be so open to the public, EFFECTIVE JULY 1, 2021.

EFFECTIVE JULY 19, 2021, ALL the magisterial district court offices throughout the thirty-second (32nd) judicial district (Delaware County) SHALL be open to the public for the conducting of

various hearings and/or trials as the attached protocol and/or appended schedules direct, as well as for private criminal complaints³ being then lodged.

That directed above as subsequent material circumstances warrant and/or it otherwise believes appropriate may be revisited by this court and modified to meet the evolving concerns presented by the ongoing COVID-19 public health crisis.

To the extent possible and practical under the material circumstances, notice of this order has been and/or will promptly be posted about the Delaware County courthouse, including but not limited to the complex's entry doors, the Delaware County Office of Judicial Support, the Court Administrator's Office of Delaware County, the Criminal Court Administrator's Office, the court's website, all magisterial district court facilities within Delaware County, the Delaware County Bar Association's website, and submitted to the Administrative Office of Pennsylvania Courts ("AOPC") for posting on the Commonwealth's Unified Judicial System's website per Pa.R.J.A. No. 1952(C)(5).4

THIRTY-SECOND (32ND – DELAWARE COUNTY) JUDICIAL DISTRICT

MAGISTERIAL DISTRICT COURT TRANSITIONAL, POST-PANDEMIC SCHEDULING AND OPERATIONAL PROTOCOLS.

PURPOSE

Recognizing the Supreme Court of Pennsylvania has directed, *inter alia*, that the Commonwealth's judicial districts must continue making constant best efforts to accomplish a full-scale processing of cases and that the COVID-19 public health crisis has as of this date been notably abated, along with a related and significant lessening by applicable governmental authorities of the previously imposed coronavirus mitigation restrictions, this court in consultation with core systematic stakeholders has developed and is implementing the following described plan as what is anticipated to be one of purposefully measured, transitional, operational increments realizing the balance between the utmost concern of the judiciary for the safety of court staff, all counsel, every litigant, the various witnesses of the parties, and the public generally, while also being mindful of the necessity to once more provide with comprehensive regularity for the timely administration of justice.

That instructed below as subsequent material circumstances warrant and/or it otherwise believes appropriate may be revisited by this court without advanced notice and modified to meet subsequent concerns, if any, presented by the currently fading COVID-19 public health crisis.

GENERAL SAFETY and OPERATIONAL DIRECTIVES

ALL persons entering ANY magisterial district court facility MUST be in FULL COMPLIANCE with ALL federal, state and/or county directives then in place to stem the coronavirus spread, if any, and as may be applicable to a given individual (*E.g.* Fully vaccinated and two (2) weeks subsequent to a final such inoculation shot or unvaccinated).

ANY litigant, lawyer, witness and/or other interested party experiencing a dry, persistent cough, shortness of breath-difficulty breathing, chills, muscle pain, sore throat, headache, a loss of smell or taste without congestion, and/or a fever greater than 99.5 Fahrenheit if taken with a temporal thermometer MUST NOT report as scheduled, but rather PROMPTLY notify the presiding Magisterial District Judge's office that he or she is suffering from such symptoms. (If unaware of the assigned and/or presiding judge, an interested party should instead contact the Magisterial District Court Administrator's Office – 610 565-6990.)

ANY litigant, lawyer, witness and/or other interested party having been tested and/or diagnosed by a physician positive for COVID-19 AND resultantly still being under a medical professional's quarantine instruction SHALL NOT report as scheduled, but instead MUST PROMPTLY notify PRIOR TO THE LISTED DATE the Magisterial District Court Administration Office (610 565-6990) of the same and follow the direction that office then provides.

ANY member of the general public experiencing a dry, persistent cough, shortness of breath-difficulty breathing, chills, muscle pain, sore throat, headache, a loss of smell or taste without congestion, and/or a fever greater than 99.5 Fahrenheit if taken with a temporal thermometer SHALL NOT enter any local court office.

ANY member of the general public havening been past tested and/or diagnosed by a physician positive for the coronavirus AND resultantly yet being under a medical professional's quarantine directive SHALL NOT then enter a magisterial district court facility.

The present routine via such a past order of this court¹ that sworn personnel of the Delaware County Park Police and/or Pennsylvania State Constables are to staff the entrances of any local court office open to the public for purposes of conducting health screenings, as well as to assure compliance with COVID-19 mitigation spread governmental directives, SHALL remain in effect through the close of business on FRIDAY, JULY 16, 2021, upon which this practice will then end.

CRIMINAL CASE PROCESSINGS

Through and including the evening of **SUNDAY**, **JULY 18**, **2021**, the present protocol for the video-only-preliminary arraignments as provided in the April 21, 2021, emergent order and appended protocol² **SHALL** remain in effect.

BEGINNING MONDAY, JULY 19, 2021, Magisterial District Judges may at their discretion conduct in-person, criminal preliminary arraignments for recent arrestees in local court offices DURING REGULAR BUSINESS HOURS ONLY (*I.e.* Monday through Friday – 8:30 a.m. to 4:30 p.m., excepting holidays).³ Should the Magisterial District Judge of original jurisdiction not be available during normal business hours (*I.e.* Monday through Friday – 8:30 a.m. to 4:30 p.m., excluding holidays), ANY such preliminary arraignments MUST be conducted via the attached video-only-arraignment schedule⁴ as is further detailed below. ALL evening, weekend and/or holiday preliminary arraignments SHALL be held as is additionally described below per the video-only-arraignment schedule.⁵ The on-duty Magisterial District Judge will also as part of that coverage conduct by advanced communication technologies (ACT) preliminary arraignments for inmate-prisoners otherwise incarcerated at local, state and/or federal penal institutions with those listings being scheduled by the Magisterial District Court Administration Office.

NO arrestees and/or prisoners SHALL due to security and/or safety concerns be permitted in ANY video-only-arraignment location. Relatedly, ALL criminal preliminary arraignments conducted at a video-only location SHALL be held via ACT (advanced communication technologies) ONLY, including but not limited to during normal business hours (*I.e.* Monday through Friday – 8:30 a.m. to 4:30 p.m., excepting holidays).

Consistent with normal operations, Magisterial District Judges scheduled for video-only-arraignments MUST also be reasonably available as requested by law enforcement personnel to review and process both criminal complaints, as well as arrest and/or search warrant applications. Magisterial District Judges listed for video-only-arraignment coverage SHALL remain on-call to address arrest and/or search warrant requests after their on-duty shift is over until the shift of the next on-duty Magisterial District Judge begins.

Through the evening of **SUNDAY**, **JULY 18**, **2021**, video-only-arraignments will continue to be conducted at District Court 32-2-46, 939 North Providence Road, Media, Pennsylvania, 19063-1403. **STARTING MONDAY**, **JULY 19**, **2021**, the video-only-arraignment site will relocate to District Court 32-1-28, 349 West Baltimore Avenue, Media, Pennsylvania, 19063-2609.

Recognizing the current video-only-arraignment coverage was crafted based on the *interim*, regionalized hearing schedules no longer in effect as of July 19, 2021, and that such coverage conflicts in modest part with the post-pandemic criminal hearing schedules of some local courts, the following changes have been made to the video-only-arraignment schedule:⁶

July 27, 2021 – MDJ Lang is reassigned in lieu of MDJ Krull.

July 29, 2021 – MDJ Krull is reassigned instead of MDJ Lang.

August 15, 2021 – MDJ Krull is reassigned in lieu of MDJ Grimes.

August 16, 2021 – MDJ Grimes is reassigned instead or MDJ Krull.

August 31, 2021 – MDJ Holefelder is reassigned in lieu of MDJ D'Agostino.

September 1, 2021 – MDJ D'Agostino is reassigned instead of MDJ Holefelder.

Relatedly, the Administration Office for Magisterial District Courts **SHALL** coordinate **PROMPTLY** any additional changes to the video-only-arraignment coverage schedule as may be needed to exchange such assignments between Magisterial District Judges resulting from the non-criminal calendars per that further detailed below.

PROTECTION FROM ABUSE MATTERS

Magisterial District Judges in Delaware County (thirty-second (32nd) judicial district) SHALL remain available after hours, on weekends and/or holidays, as well as any other such times this court may subsequently direct, to review and decide per the attached coverage schedule emergency protection from abuse applications.⁷ ALL such emergent protection from abuse requests are to be addressed by the covering Magisterial District Judge through some type of advanced communication technologies (ACT), including but not limited to video conferencing, FaceTime, Skype, Polycom, Microsoft Teams, Zoom, etc., and while a technological means

allowing for both visual and audio capabilities is preferred, telephonic or audio only emergency protection from abuse hearings **SHALL** be **PERMITTED** should a combined audio and visual connection between the applicant and Magisterial District Judge not be reasonably available. The covering Magisterial District Judge may in his or her discretion grounded on compelling circumstances entertain an *in-person* emergency protection from abuse application.

Beyond ALL emergent protection from abuse requests being received by the covering Magisterial District Judge through some means of advanced communication technologies (ACT), absent compelling circumstances necessitating at the local judge's discretion such an *in-person* review, as previously agreed to by the Delaware County Police Chiefs Association with this court's gratitude, salient law enforcement will facilitate needed contact between a protection from abuse applicant and the on-duty Magisterial District Judge, promptly assist in providing the petitioner a copy of the protective order the magisterial district court may issue, and/or timely make efforts to serve the named respondent with the emergent order of protection.

The on-duty Magisterial District Judge MUST remain on-call to address ALL emergent protection from abuse applications after his or her shift concludes until that of the next scheduled Magisterial District Judge starts.

CRIMINAL PRELIMINARY HEARINGS

ALL Magisterial District Judges will continue conducting preliminary hearings in criminal matters in accord with the protocols directed by this court's Seventh Emergency Order Extension – Magisterial District Court Operations⁸ through and including Friday, July 16, 2021.

EFFECTIVE MONDAY, JULY 19, 2021,9 each magisterial district court SHALL hold criminal preliminary hearings on those days and at those locations designated per the appended MDJ court criminal hearing schedule. 10

ALL magisterial district courts SHALL begin conducting *in-person* preliminary hearings for incarcerated accuseds commencing MONDAY, JULY 19, 2021.¹¹ Local court staff when scheduling for imprisoned accuseds *in-person* preliminary hearings SHALL give ABSOLUTE PRIORITY to the initial listing of such matters first filed and then those more recently lodged. As part of their crafting these *in-person*, incarcerated accuseds preliminary hearing lists, local court staff MUST coordinate the same with the Magisterial District Court Administration Office.

In ongoing consultation with the prisoner transportation team for the local courts, **EACH** Magisterial District Judges will currently being modestly limited in the maximum number of inmates able to be custodial transported on a given preliminary hearing date as the attached MDJ court prisoner transport schedule¹² additionally details. There are for now **NO EXCEPTIONS** to these respective prisoner transportation hearing date caps.¹³

The present protocol directing for imprisoned accuseds so agreeable the scheduling of video preliminary hearings SHALL remain in effect through and including THURSDAY, JULY 15, 2021, upon which the listing of these "virtual" proceedings will end.¹⁴

Recognizing that a number of preliminary hearings have already been listed at one of the four (4), *interim*, regionalized magisterial district court offices so designated by such an immediate past protocol, ¹⁵ local court personnel **SHALL IMMEDIATELY** begin rescheduling **ALL** such cases consistent with the appended MDJ court criminal hearing schedule ¹⁶ and **PROMPTLY** provide **ALL** interested parties written notice of the relisted date, time and location.

Because the Upper Darby Police Station no longer has an operational courtroom, the criminal preliminary hearings previously listed at that location (District Court Nos. 32-1-35, 32-2-51, 32-1-34 and 32-1-33) will instead be scheduled and held at district court 32-2-47, 60 West Marshall Road, Lansdowne, Pennsylvania, 19050, **EFFECTIVE JULY 19, 2021**. As is further detailed above, with magisterial district court 32-1-28 being utilized for video-only-preliminary arraignments that local court's (magisterial district court No. 32-1-28) preliminary hearings will be held at district court 32-2-46, 939 North Providence Road, Media, Pennsylvania 19063-1403, **EFFECTIVE JULY 19, 2021**.

PRIVATE CRIMINAL COMPLAINTS

Beginning MONDAY, JULY 19, 2021, ALL local court facilities will accept and process private criminal complaints as prescribed by the applicable Pennsylvania Rule of Criminal Procedure¹⁷ and otherwise in accord with local practices (*E.g.* on completion of the required documents, the private criminal complainant is to be directed to the Delaware County District Attorney's Office (Delaware County Courthouse, 201 West Front Street, Media, Pennsylvania, 19063) for the private criminal complaint's review and approval or disapproval).

NON-CRIMINAL HEARINGS18

ALL Magisterial District Judges SHALL continue through and including FRIDAY, JULY 16, 2021, conducting hearings in non-criminal matters¹⁹ under the protocols provided in this court's immediate past emergent order directing local court operations.²⁰

BEGINNING MONDAY, JULY 19, 2021, EACH local court SHALL conduct ALL non-criminal hearings²¹ in their own magisterial district court facility, excepting district court 32-1-28, which will hold ALL such proceedings at magisterial district court 32-2-46, 939 North Providence Road, Media, Pennsylvania, 19063-1403.²²

ALL Magisterial District Judges SHALL provide as soon as reasonably practicable to the Magisterial District Court Administration Office a proposed schedule for ALL non-criminal matters. Non-criminal matters may be scheduled at each Magisterial District Judge's discretion; however, NO such listings can conflict with the appended MDJ court criminal hearing schedule. Those local judges sharing court facilities are to coordinate the listing of non-criminal matters with each other to avoid scheduling conflicts.

Recognizing that a number of non-criminal matters²⁷ have already been set consistent with this court's immediate past emergent order regarding magisterial district court operations,²⁸ local court personnel **SHALL** timely reschedule the same in accord with that which this protocol directs

and PROMPTLY provide ALL interested parties written notice of the relisted date, time and location.

LANDLORD-TENANT ACTIONS – DELAWARE COUNTY EMERGENCY RENTAL ASSISTANCE PROGRAM

EFFECTIVE IMMEDIATELY, the Office of the Magisterial District Court Administrator SHALL cause ALL local court facilities to have prominently displayed in an area frequented by the public, preferably in proximity to the filing – transaction windows, at least one (1) full-sized poster detailing the Delaware County Emergency Rental Assistance Program. (As a function of a given magisterial district court facility's public lobby's area size, more than one (1) such poster should be notably shown.)

The Magisterial District Court Administration Office **SHALL** cause to be placed in **EVERY** local court facility at the transaction windows where filings are processed and otherwise readily accessible to the public a sufficient number of flyers about the Delaware County Emergency Rental Assistance Program, **EFFECTIVE IMMEDIATELY**. The Office of Magisterial District Court Administration **SHALL** in concert with **ALL** local court coordinators assure moving forward that **EVERY** magisterial district court facility in the thirty-second (32nd) judicial district (Delaware County) always has on-hand an adequate number of these Delaware County Emergency Rental Assistance Program flyers.

EFFECTIVE IMMEDIATELY, ALL local court personnel **SHALL** on the lodging of a landlord-tenant action provide to the filing individual a Delaware County Emergency Rental Assistance Program flyer, along with the normally expected paperwork returned in such an action to the landlord and/or his or her counsel.

When preparing for service by a Pennsylvania State Constable or any other person the documents attendant to a landlord-tenant action, including but not limited to original process (*E.g.* complaints) eviction notices and/or eviction orders, **ALL** magisterial district court staff **SHALL** make as part of those materials, a Delaware County Emergency Rental Assistance Program flyer, **EFFECTIVE IMMEDIATELY.**

The Magisterial District Judges are in entertaining continuance applications in landlord-tenant actions to give due consideration to either and/or both litigants' reasonable, good faith efforts to participate in the Delaware County Emergency Rental Assistance Program and the time reasonably needed to pursue and effectuate the same.

FILINGS and OTHER TRANSACTIONS

The current protocols²⁹ directing non-criminal filings³⁰ and other transactions **SHALL** remain in effect through and including Wednesday, June 30, 2021. **EFFECTIVE THURSDAY**, **JULY 1, 2021**, **EACH** local court facility **SHALL** be open to the general public for purpose of accepting non-criminal filings,³¹ bail postings and payments otherwise, as well as **ANY** transactions consistent with usual business practices previous to this court's emergency

declaration³² (pre-pandemic) and its attendant emergency orders comprehensively directing magisterial district court operations.

ISSUANCE and SERVICE OF WARRANTS BY CONSTABLES

EFFECTIVE MONDAY, JULY 19, 2021, ALL magisterial district courts may resume issuing warrants to those constables approved for such work in the thirty-second (32nd) judicial district, and the constables may relatedly as of that same date (July 19, 2021) resume serving those warrants.
