AMENDED PRESIDENT JUDGE ADMINISTRATIVE ORDER

AND NOW, this 10<sup>th</sup> day of November, 2021, it is hereby **ORDERED** and **DECREED** in consultation with the Magisterial District Court Administrator that the local court operational and scheduling protocols of August 12, 2021, SHALL be **AMENDED** to reflect, *inter alia*, an increase for certain Magisterial District Courts in the maximum number of inmates able to be custodially transported on a given preliminary date, **EFFECTIVE IMMEDIATELY**.

Except to the extent ordered above, this court's President Judge Administrative Order – Magisterial District Courts – Operational and Scheduling Protocols dated August 12, 2021,<sup>3</sup> SHALL remain in full force and effect.

That directed above and/or via the attached protocols as subsequent, material circumstances warrant and/or it is otherwise believed appropriate may be revisited by the court and modified, in whole or part.

# THIRTY-SECOND (32<sup>ND</sup> – DELAWARE COUNTY) JUDICIAL DISTRICT

# MAGISTERIAL DISTRICT COURT SCHEDULING AND OPERATIONAL PROTOCOLS

#### **PURPOSE**

Recognizing the Supreme Court of Pennsylvania has directed, *inter alia*, that the commonwealth's judicial districts must continue making constant best efforts to accomplish a full-scale processing of cases and that the COVID-19 public health crisis has as of this date been notably abated, albeit with ongoing modifications by applicable governmental authorities of the previously imposed coronavirus mitigation restrictions, this court having identified from a review of the local courts' emergent business processes¹ in consultation with the Magisterial District Court Administrator various of those systematic efficiencies and wanting to promote the same moving forward has developed and is implementing the following Magisterial District Court Operational and Scheduling Protocols.²

That instructed below as subsequent material circumstances warrant and/or it otherwise believes appropriate may be revisited by this court without advanced notice and modified to meet subsequent concerns, if any, presented by the still continuing COVID-19 public health crisis and/or as it believes attendant to realizing judicial districtwide efficiencies.

#### GENERAL SAFETY and OPERATIONAL DIRECTIVES

ALL persons entering ANY magisterial district court facility MUST be in FULL COMPLIANCE with ALL federal and/or state directives then in place to stem the coronavirus spread, if any, and as may be applicable to a given individual (*E.g.* fully vaccinated and two (2) weeks subsequent to a final such inoculation shot or unvaccinated).

ANY litigant, lawyer, witness and/or other interested party experiencing a dry, persistent cough, shortness of breath-difficulty breathing, chills, muscle pain, sore throat, headache, a loss of smell or taste without congestion, and/or a fever greater than 99.5 Fahrenheit if taken with a temporal thermometer MUST NOT report as scheduled, but rather PROMPTLY notify the presiding Magisterial District Judge's office that he or she is suffering from such symptoms. (If unaware of the assigned and/or presiding judge, an interested party should instead contact the Magisterial District Court Administrator's Office – 610 565-6990.)

ANY litigant, lawyer, witness and/or other interested party having been tested and/or diagnosed by a physician positive for COVID-19 AND resultantly still being under a medical professional's quarantine instruction SHALL NOT report as scheduled, but instead MUST PROMPTLY notify PRIOR TO THE LISTED DATE the Magisterial District Court Administration Office (610 565-6990) of the same and follow the direction that office then provides.

**ANY** member of the general public experiencing a dry, persistent cough, shortness of breath-difficulty breathing, chills, muscle pain, sore throat, headache, a loss of smell or taste without congestion, and/or a fever greater than 99.5 Fahrenheit if taken with a temporal thermometer **SHALL NOT** enter any local court office.

ANY member of the general public having been past tested and/or diagnosed by a physician positive for the coronavirus AND resultantly yet being under a medical professional's quarantine directive SHALL NOT then enter a magisterial district court facility.

#### CRIMINAL CASE PROCESSINGS

Magisterial District Judges *may* at their discretion conduct *in-person*, criminal preliminary arraignments for recent arrestees in local court offices **DURING REGULAR BUSINESS HOURS ONLY** (*I.e.* Monday through Friday – 8:30 a.m. to 4:30 p.m., excepting holidays).<sup>3</sup>
Should the Magisterial District Judge of original jurisdiction not be available during normal business hours (*I.e.* Monday through Friday – 8:30 a.m. to 4:30 p.m., excluding holidays), **ANY** such preliminary arraignments **MUST** be conducted via the video-only-arraignment schedule<sup>4</sup> timely distributed and kept current by the Office of the Magisterial District Court Administrator as is further detailed below. **ALL** evening, weekend and/or holiday preliminary arraignments **SHALL** be held as is additionally described below per such a video-only-arraignment schedule.<sup>5</sup> The on-duty Magisterial District Judge will also as part of that coverage conduct by advanced communication technologies ("ACT") preliminary arraignments for inmate-prisoners otherwise incarcerated at local, state and/or federal penal institutions with those listings being scheduled by the Magisterial District Court Administration Office.<sup>6</sup>

NO arrestees and/or prisoners SHALL be permitted due to security and/or safety concerns in ANY video-only-arraignment location. Relatedly, ALL criminal preliminary arraignments conducted at a video-only location SHALL be held via ACT (advanced communication technologies) ONLY, including but not limited to during normal business hours (*I.e.* Monday through Friday – 8:30 a.m. to 4:30 p.m., excepting holidays).

Magisterial District Judges scheduled for video-only-arraignments MUST also be reasonably available as requested by law enforcement personnel to review and process both criminal complaints, as well as arrest and/or search warrant applications. Magisterial District Judges listed for video-only-arraignment coverage SHALL remain on-call to address arrest and/or

search warrant requests after their such scheduled hours are over until the shift of the next on-duty Magisterial District Judge begins.

The video-only-arraignment site will remain located at District Court 32-1-28, 349 West Baltimore Avenue, Media, Pennsylvania, 19063-2609.

The Administration Office for Magisterial District Courts **SHALL** continue to promptly coordinate any additional changes to the video-only-arraignment coverage schedule as may be needed to exchange such assignments between Magisterial District Judges resulting from the non-criminal calendars per that further detailed below.

#### PROTECTION FROM ABUSE MATTERS

Magisterial District Judges in Delaware County (thirty-second (32<sup>nd</sup>) judicial district) **SHALL** remain available after hours, on weekends and/or holidays, as well as any other such times this court may otherwise direct, to review and decide per the attached coverage schedule emergency protection from abuse applications.<sup>7</sup> **ALL** such emergent protection from abuse requests are to be addressed by the covering Magisterial District Judge through some type of advanced communication technologies ("ACT"), including but not limited to video conferencing, FaceTime, Skype, Polycom, Microsoft Teams, Zoom, *etc.*, and while a technological means allowing for both visual and audio capabilities is preferred, telephonic or audio only emergency protection from abuse hearings **SHALL** be **PERMITTED** should a combined audio and visual connection between the applicant and Magisterial District Judge not be reasonably available. The on-duty Magisterial District Judge may in his or her discretion grounded on compelling circumstances entertain an *in-person* emergency protection from abuse application.<sup>8</sup>

Beyond ALL emergent protection from abuse requests being received by the covering Magisterial District Judge through some means of advanced communication technologies ("ACT"), absent compelling circumstances necessitating at the local judge's discretion such an *inperson* review, as previously agreed to by the Delaware County Police Chiefs Association with this court's gratitude, salient law enforcement will facilitate needed contact between a protection from abuse applicant and the covering Magisterial District Judge, promptly assist in providing the petitioner a copy of the protective order the magisterial district court may issue, and/or timely make efforts to serve the named respondent with the emergent order of protection.

The on-duty Magisterial District Judge MUST remain on-call to address ALL emergent protection from abuse applications after his or her shift concludes until that of the next scheduled Magisterial District Judge starts.

#### CRIMINAL PRELIMINARY HEARINGS

Each magisterial district court **SHALL** continue to hold criminal preliminary hearings on those days and at those locations designated per the appended MDJ court criminal hearing schedule.<sup>9</sup>

Local court staff when scheduling for imprisoned accuseds *in-person* preliminary hearings **SHALL** give **PRIORITY** to the initial listing of such matters first filed and then those more recently lodged. As part of their crafting these *in-person*, incarcerated accuseds preliminary hearing lists, local court staff **MUST** continue to coordinate the same with the Magisterial District Court Administration Office.

In ongoing consultation with the prisoner transportation team for the local courts, **EACH** Magisterial District Judge will yet be modestly limited in the maximum number of inmates able to be custodial transported on a given preliminary hearing date as the attached MDJ court prisoner transport schedule<sup>10</sup> additionally details. There are for now **NO EXCEPTIONS** to these respective prisoner transportation hearing date caps.<sup>11</sup>

ALL cases in which some form of criminal homicide<sup>12</sup> is charged<sup>13</sup> MUST for purposes of preliminary hearings be scheduled through the Office of Magisterial District Court Administration. Salient personnel of the Magisterial District Court Administration Office after discussion with the involved Magisterial District Judge are to timely and specially list ALL homicide<sup>14</sup> preliminary hearings.<sup>15</sup>

Because the Upper Darby Police Station no longer has an operational courtroom, the criminal preliminary hearings previously listed at that location (District Court Nos. 32-1-35, 32-2-51, 32-1-34 and 32-1-33) will be scheduled and held at District Court 32-2-47, 60 West Marshall Road, Lansdowne, Pennsylvania, 19050. As is further detailed above, with Magisterial District Court 32-1-28 being utilized for video-only-preliminary arraignments that local court's (Magisterial District Court No. 32-1-28) preliminary hearings will still be held at District Court 32-2-46, 939 North Providence Road, Media, Pennsylvania 19063-1403.

### PRIVATE CRIMINAL COMPLAINTS

ALL local court facilities will accept and process private criminal complaints as prescribed by the applicable Pennsylvania Rule of Criminal Procedure<sup>16</sup> and otherwise in accord with local practices (*E.g.* on completion of the required documents, the private criminal complainant is to be directed to the Delaware County District Attorney's Office (Delaware County Courthouse, 201 West Front Street, Media, Pennsylvania, 19063) for the private criminal complaint's review and approval or disapproval).

### NON-CRIMINAL HEARINGS17

**EACH** local court **SHALL** conduct **ALL** non-criminal hearings<sup>18</sup> in their own magisterial district court facility, excepting District Court 32-1-28, which will hold **ALL** such proceedings at Magisterial District Court 32-2-46, 939 North Providence Road, Media, Pennsylvania, 19063-1403.<sup>19</sup>

Non-criminal matters<sup>20</sup> may be scheduled at each Magisterial District Judge's discretion; however, **NO** such listings can conflict with the appended MDJ court criminal hearing schedule.<sup>21</sup> Those local judges sharing court facilities are to coordinate the listing of non-criminal matters<sup>22</sup> with each other to avoid scheduling conflicts.

### LANDLORD-TENANT ACTIONS – DELAWARE COUNTY EMERGENCY RENTAL ASSISTANCE PROGRAM

The Office of the Magisterial District Court Administrator SHALL continue to cause ALL local court facilities to have prominently displayed in an area frequented by the public, preferably in proximity to the filing – transaction windows, at least one (1) full-sized poster detailing the Delaware County Emergency Rental Assistance Program. (As a function of a given magisterial district court facility's public lobby's area size, more than one (1) such poster should be notably shown.)

The Magisterial District Court Administration Office **SHALL** continue to cause to be placed in **EVERY** local court facility at the transaction windows where filings are processed and otherwise readily accessible to the public a sufficient number of flyers about the Delaware County Emergency Rental Assistance Program. The Office of Magisterial District Court Administration **SHALL** in concert with **ALL** local court coordinators assure that **EVERY** magisterial district court facility in the thirty-second (32<sup>nd</sup>) judicial district (Delaware County) always has on-hand an adequate number of these Delaware County Emergency Rental Assistance Program flyers.

**ALL** local court personnel on the lodging of a landlord-tenant action **SHALL** still provide to the filing individual a Delaware County Emergency Rental Assistance Program flyer, along with the normally expected paperwork returned in such an action to the landlord and/or his or her counsel.

When preparing for service by a Pennsylvania State Constable or any other person the documents attendant to a landlord-tenant action, including but not limited to original process (*E.g.* complaints) eviction notices and/or eviction orders, **ALL** magisterial district court staff **SHALL** yet make as part of those materials, a Delaware County Emergency Rental Assistance Program flyer.

The Magisterial District Judges are in entertaining continuance applications in landlord-tenant actions to give due consideration to either and/or both litigants' good faith efforts to participate in the Delaware County Emergency Rental Assistance Program and the time reasonably needed to pursue and effectuate the same.

#### ISSUANCE and SERVICE OF WARRANTS BY CONSTABLES

**ALL** magisterial district courts can continue issuing warrants to those constables approved for such work in the thirty-second (32<sup>nd</sup>) judicial district (Delaware County), and the constables may in accord with applicable law serve those warrants.
