**SPECIAL RULES AND REGULATIONS GOVERNING SEXUAL OFFENDERS ON PROBATION**  
**AND/OR PAROLE**

I, \_\_\_\_\_, will abide by the following rules and regulations:  
Defendant's Name

1. You will participate in and successfully complete a Sexual Offender treatment program. You understand, you will be referred to this program by your Probation/Parole Officer. You also understand that information will be shared between your Probation/Parole Officer and the Treating Professional.
2. You will undergo periodic polygraph examinations as recommended by your Probation/Parole Officer or treatment provider to determine compliance with the conditions of supervision and treatment. You are responsible for paying the cost of these examinations and treatment
3. You will refrain from possessing, owning or consuming any alcohol if your offense occurred under the influence of alcohol or if a treating professional deems it appropriate. You will not attend any meetings with your Probation/Parole Officer, the courts or any treatment agency under the influence of drugs or alcohol.
4. You will have no direct or indirect contact with the victim(s) of your offense.
5. If your offense involved a minor, you will have no contact with minors (persons under the age of eighteen) or incapacitated persons without a responsible adult present. The adult present is one who has been informed of your conviction(s) and the circumstances surrounding it, and has been approved by your Probation/Parole Officer.
6. If your offense involved a minor, you will not obtain employment with or operate any agency/place of business nor volunteer for the same, when the agency provides services for the care/ custody of persons under the age of eighteen (18).
7. If your offense involved a minor, you are not permitted to live with any minors for any reason unless approved by the court.
8. You will not have any pornographic material of any kind in your possession at any time. Pornography includes any visual representation, photograph, picture, motion picture or computer-generated image if the subject matter depicts ultimate sexual acts, normal or perverted, actual or simulated, masturbation, excretory functions or lewd exhibition of the genitals. A search of your person, your personal computer, your residence, and your vehicle may be made at any time.
9. Your residence and living situation must be approved by the Office of Probation and Parole.
10. You must notify your Probation/Parole Officer prior to changing and /or terminating employment.
11. Your daily travel is limited to adjoining counties. Any travel beyond those counties or overnight travel must be approved by your officer prior to departure. You cannot travel outside of the Commonwealth of Pennsylvania.
