

Health Providers

Program: Children's Hospital of Philadelphia - Resilience After Infant Substance Exposure

Total Amount: \$68,567

Clinical service which provides longitudinal neurodevelopmental monitoring and care coordination to identify points of intervention within family strengths and areas of need to improve the well-being, health and developmental outcomes for infants and children diagnosed with Neonatal Abstinence Syndrome or Neonatal Opioid Withdrawal Syndrome.

Program: Children's Hospital of Philadelphia - Substance Use Harm Reduction for Families

Total Amount: \$175,391

Program designed to build capacity in overdose prevention and treatment services by supporting the public, clinicians, recovery professionals, and first responders by providing real-time coaching through initiating Medication Assisted Treatment, administering naloxone, poisoning prevention train-the-trainer events, and real-time surveillance for needs assessment and program evaluation.

Program: Nemours Children's Health - Prevention Education

Total Amount: \$100,000

Provide education at four events, one being an Opioid Awareness Day program and the remaining three at schools within the higher population densities communities in the County, designed to increase awareness of risks, prevention, and treatment among adolescents and their families.

Program: Penn's Center for Addiction Medicine and Policy - CareConnect Warmline

Total Amount: \$173,098

Expansion of CareConnect Warmline, currently operating in Philadelphia, which provides a low-barrier safety net to buprenorphine and substance use navigation services, to Delaware County.

Total amount for all Health Providers: \$517,056

Service Providers

Program: Merakey – Warm handoff/Recovery Program Expansion

Total Amount: \$81,010

Expansion and enhancement of the forensic services through case management and peer services to support individuals while incarcerated, when approaching release, when integrating into the community, and participating in diversion courts.

Program: Mirmont Treatment Center - Warm Handoff Pregnancy Pilot Program

Total Amount: \$625,629

Expansion of outreach services to connect pregnant women to the resources Delaware County offers, including inpatient and outpatient treatment, programs offered through Main Line Health, and case management during and after birth.

Program: Multicultural Community Family Services - Prevention

Total Amount: \$108,729.74

Program designed to combat the opioid crisis within the immigrant community through media campaigns to prevent opioid misuse by engaging non-profits and faith-based communities as systems to support prevention.

Program: MVP Recovery – Medication Assisted Treatment Start-Up

Total Amount: \$861,640

Start-up costs to develop the Narcotic Treatment Program at the Chester site to provide Medication Assisted Treatment, including a Partial Hospitalization Program and Certified Recovery Specialists.

Program: The Shevlin Family Foundation – First Helps Program

Total Amount: \$45,880

Proposal to provide financial assistance through gift cards and money orders for basic needs to persons beginning recovery, staffing to monitor the program, and a portion of the recovery software utilized to track participant's recovery journey and ongoing care coordination.

Program: The Shevlin Family Foundation – Nurturing Sober Communities

Total Amount: \$23,000

Proposal to enhance provider's ability to nurture sober communities through community events, such as Recovery Fest, Overdose Awareness and Memorial Walk, and Phillies Game for persons in recovery; and facilitation of Recovery Home Coalition Meetings.

Program: The Shevlin Family Foundation – Stabilization and Enhancement of the Journey Program

Total Amount: \$60,430

Proposal to increase capacity to provide ongoing recovery support to persons in the Journey Program by adding Certified Recovery Specialists on a part-time basis to establish and maintain regular contact with the individuals.

Program: Community Action Agency - Assessment and Therapy for Homeless and Near Homeless

Households

Total Amount: \$150,132

Provide screening and assessment for persons experiencing homelessness or near homelessness, and

therapy for those who are identified as having issues related to opioid or other substance use.

Program: American Treatment Network - Opioid Crisis Response Center

Total Amount: 1,500,000

Opioid Crisis Response Center, located in Upland, to provide three primary services: Opioid Treatment Program with a full continuum of treatment services; in-person 24-hour assessment center; and 23-hour reclines for individuals awaiting placement in treatment services.

Program: Savage Sisters Recovery, Inc. - Community Recovery: Housing, Education, Harm Reduction, and

Outreach (Submitted by Public Defender's Office)

Total Amount: \$537,000

Expand evidence-based services, including recovery housing, education, harm reduction, and outreach, currently operational in Philadelphia to Delaware County.

Total Service Providers: \$3,993,451

Higher Education

Program: Saint Joesph's University – CEU Program Targeting Pharmacy-Related Providers

Total Amount: \$180,900

Online, asynchronous continuing educational program for pharmacists addressing critical areas such as reducing the stigma surrounding Opioid Use Disorder, implementing screening techniques, intervening when necessary, and appropriately referring patients to local resources.

Program: Saint Joesph's University - Opioid Addiction Education and Prevention Series for Medical

Residents and Medical Students

Total Amount: \$157,500

Prevention-based educational series, addressing themes of recognizing addition, safe prescribing practices, and alternative forms of chronic pain management, for medical residents and medical students.

Program: Saint Joesph's University – Working Group to Develop Curriculum for K-12 Students Focused on

Opioid Prevention and Education

Total Amount: \$62,500

Convene a workgroup to evaluate and enhance the Institute for Clinical Bioethics' comprehensive education and prevention curriculum to be deployed at County Schools.

Program: Widener University – Opioid Service Delivery Expansion Program

Total Amount: \$146,419

Enhance the clinical experience of predoctoral interns to increase training experiences related to developing core competencies required for working with the vulnerable and underserved populations impacted by the opioid crisis, design and implement inter-professional learning, and increase the standard of integrated clinical practice.

Program: Pennsylvania Institute of Technology – Education and Training

Total Amount: \$66,500

Implement opioid education initiatives that would strengthen current healthcare-related curricula intended toward future practitioners and would provide educational opportunities and resources for the community.

Total Higher education: \$613,819

County Departments

Program: Health Department - Delco Revive

Total Amount: \$137,286

Expansion of Delco Revive to provide leave-behind kits, CPR Certification, MRC training support, and marketing campaign.

Program: Department of Human Services-Drug and Alcohol – Targeted Case Management for Pregnant

Women and Women with Children

Total Amount: \$80,000

Amend current contractual agreements with service providers to include a specialized case management track geared towards pregnant women and women with children.

Program: Department of Human Services-Drug and Alcohol - Transportation Services

Total Amount: \$50,000

Add transportation to current contractual agreements with service providers to reduce the identified barrier to accessing treatment.

Program: Medical Examiner's Office - Randox Evidence MultiSTAT Analyzer

Total Amount: \$60,030

Purchase of the Randox Evidence MultiSTAT Analyzer which is a diagnostic testing system designed to rapidly and simultaneously test multiple analytes in various samples.

Program: Health Department – Deterra

Total Amount: \$1,000,000

Proposal to contract with Deterra to distribute drug disposal pouches, which allow for safe medication disposal at home, and will include a customized postcard with a greeting from the County and health education information about medication safety and opioid harm reduction.
