PRINTING PETITION FROM BUREAU OF ELECTIONS WEB SITE?

Be certain to print the Nomination Petition as DUPLEX (two-sided, Front and Back Head to Head) on plain white **8 ½" X 11" (Letter Size) paper.**

Please read the following guidelines carefully before circulating and submitting Nomination Petitions. Be certain to read all sections of the actual Nomination Petition prior to circulation.

First Day to Circulate Nomination Petitions: February 18, 2025
Last day to File Nomination Petitions: March 11, 2025

1. The Delaware County Bureau of Elections is the supervisor for elections of county and local level offices. Candidates seeking state office must contact the Pennsylvania Department of State.
2. If you printed your Nomination Petition from Bureau of Elections' website, there is a PDF of the Nomination Petition and instructions, be certain to print the Nomination Petition as DUPLEX (two-sided, Front and Back Head to Head) on plain white 8-½" X 11" (Letter Size) paper. This requirement (by Pennsylvania State Law) **CANNOT** be satisfied by printing each side of the duplex Nomination Petition on a separate sheet and affixing the two sheets together. **Failure to reproduce the Nomination Petition forms correctly may result in the rejection of those forms.**
3. Nomination Petition forms are available at the Bureau of Elections office at the County Government Center in Media. If you are unable to visit the Bureau of Elections or print the form on your own, consult with a printing store or office-supply store.
4. Petition pages shall be numbered consecutively beginning with number one, at the foot of each petition page. Front side of petition is page 1 and back side is page 2.
5. If more than one petition page is used per office, they shall be bound (ex. clipped or stapled) together when submitted for filing.
6. **No ditto marks** are allowed.
7. Do not include a social security number on the Nomination Petition affidavits, S/S is a legal symbol for "Sworn and Subscribed to" **not** Social Security Number. Note that Nomination Petitions and all attachments are public record.

INSTRUCTIONS FOR COMPLETING THE FRONT OF THE NOMINATION PETITION

8. **❶ ELECTORAL DISTRICT**

Write the name of the "Electoral District" in which the candidate is running. The electoral district is the geographical area represented by the office the candidate is seeking.

Countywide office you may print - "Delaware County"

Magisterial District Judge for example you may print – Magisterial District Judge 32-2-44

City for example you may print - "City of Chester, Delaware County"

Township/Borough for example you may print - "Aston Township 3rd ward, Delaware County"

School District for example you may print – "Garnet Valley School District" or William Penn School District Region 3"

9. **🗳️ POLITICAL PARTY**

Enter the political party (“Democratic” or “Republican”) for which the voter’s signing the petition are enrolled

10. **👤 NAME OF CANDIDATE**

Type or print the name of the candidate EXACTLY as the candidate would like it to appear on the ballot. A derivative of a name may be used, but not a nickname. For example, registered voter Anthony P. Smith may appear on the ballot as Tony Smith, but not “Skippy” Smith

11. **👔 PROFESSION, BUSINESS, OR OCCUPATION**

For “Profession, Business, or Occupation,” write your current job title, such as “Attorney,” “Clerk,” “Accountant,” “Business Manager,” “Secretary,” or “Steel Worker.” Simply putting initials such as VP, CEO, COO, CFO is not sufficient. (Note: Retired is an acceptable entry in this line.)

12. **🏠 PLACE OF RESIDENCE**

Enter your house number (apartment number, if applicable), street name, and ZIP code.

Be certain to list post office where mail is to be sent as well as the city, borough or township of residence. The post office may be Broomall, but township is Marple or post office may be Bryn Mawr, but Township is Radnor

Example: John T. Doe
 123 Main Street, Broomall (Marple Twp) PA 19008

13. **👤 TITLE OF OFFICE**

For “Title of Office” include the office for which you are seeking election for example, Edgmont Township Auditor.

14. **🕒 TERM OF OFFICE**

For “Term of Office” insert the duration of the term of the office for which you are seeking in number of years, for example, Edgmont Township Auditor 6 year term. **If running for an unexpired term of an office state the balance of years remaining in that term, for example,** “Folcroft Borough Council 2 year Mid Term.”

15. On side two of the Nomination Petition in the Candidates Affidavit where it asks for “Election District,” the information is your registered ward/district/precinct. Example: a candidate registered in Upper Darby Twp. 1st District 5th Precinct would list Upper Darby 1-5; or a voter in Media East would list Media East. “District” does not refer to legislative or Congressional districts.

16. Candidates who **Do Not** sign the **Waiver of Expense** Account Reporting Affidavit are **required** to file candidate statements or reports according to the Campaign Finance Calendar. Blank statements and reports can be obtained from this office upon request or may be downloaded from our website. Failure to file reports in a timely manner will result in costly fines.

17. Pennsylvania Department of State has approved use of the Candidate Declaration (included with your Nomination Packet) in place of a Notary certification when notarized statement is not available. If you choose to notarize your nomination petitions, they must be notarized before filing with the Bureau of Elections.

18. Filing fees are paid in the Delaware County Treasurer’s Office prior to filing the nomination petition in the Bureau of Elections. Make certified checks or money orders payable to **Delaware County Treasurer** (cash is also acceptable). Personal checks **will not** be accepted. Filing fees will not be refunded for any reason, including the candidates withdraw.

19. The **Statement of Financial Interest** and receipt of the proper **filing fee**, if applicable **must accompany** the nomination petition upon filing in the Bureau of Elections.
A separate Statement of Financial Interest Form must be filed with the governing body for the office you are seeking.
- You should review the backside of the Statement of Financial Interest Form.
 - The chart “Who Must File, Where To File And When To File” section A identifies the Who (offices and office levels) and following right along the grid is the location of the Original filing and the Additional filing. * *
 - Countywide offices and Magisterial District Judges the Original filing is the County Clerk’s office located on the second floor of the Government Center Building and the Additional filing is filed in the Bureau of Elections with your petition.
- Both filings must be submitted on or before March 11, 2025.
20. If you wish to retain copies of your Nomination Petition for your records, make them prior to filing the petitions in the Bureau. Candidates may bring a copy of the complete nomination petition filing, and Bureau staff will date/time stamp it for your records. If you request copies of your Nomination Petitions in the Bureau, a fee of .25\$ per page will be charged. NOTE: Copies will be made within 24 hours, not instantly upon filing.
21. The last day for candidates to file petitions with the Bureau of Elections is March 11, 2025. PLEASE NOTE: We anticipate that the line of candidates waiting to file will be longest March 6 through March 11.

 - D Public Employees** - Individuals employed by the Commonwealth or a political subdivision who are responsible for taking or recommending official action of a non-ministerial nature with regard to: contracting or procurement; administering or monitoring grants or subsidies; planning or zoning; inspecting, licensing, regulating or auditing any person; or any other activity where the official action has an economic impact of greater than a de minimis nature on the interests of any person. The term does not include individuals whose activities are limited to teaching.
- A former public official or former public employee must file the year after termination of service with the Commonwealth or political subdivision.**
- E Solicitors** - Persons elected or appointed to the office of solicitor for political subdivision(s).

STATEMENT OF FINANCIAL INTERESTS INSTRUCTIONS

Please print neatly in capital letters. If you require more space than has been provided, please attach an 8 1/2" x 11" piece of paper to the form. Blocks 01 through 06 are for current information.

- Block 01** Enter your last name, first name, middle initial and suffix (if applicable) in the spaces provided. Public office candidates should use the exact name used on official nomination petition or papers.
- Block 02** List an office (business or governmental) or home address and daytime telephone number.
- Block 03** Check the box or boxes to indicate your status. See definitions on front page. If you are correcting a prior filing, please check the box designating an amended form.
- Block 04** Check the appropriate box (seeking, hold, held) for each position you list in the blocks below. List all public position(s) which you are seeking, currently hold, or have held in the **prior** calendar year. Please be sure to include job titles and official titles such as "member" or "commissioner" (even if serving as an alternate/designee).
- Block 05** List all Commonwealth agency(ies) or political subdivision(s) as to which you: (1) are presently seeking a public position or public office as a candidate (incumbent or non-incumbent) or nominee; (2) presently hold public office(s) or public employment; and/or (3) previously held a public office(s) or public employment during all or any portion of the calendar year listed in block 07. (The term "political subdivision" includes a county, city, borough, incorporated town, township, school district, vocational school, county institution, district, and any authority, entity or body organized by the aforementioned).
- Block 06** List your current occupation or profession. This information may be the same as stated in block 04.
- Block 07** List the calendar year for which you are filing this form. Like tax returns, the form discloses financial information for a **prior** calendar year. For example, for the form due May 1, 2025, block 07 would read "2024." The information in blocks 08 through 15 should represent financial interests for the calendar year listed in Block 7.
- Block 08** **REAL ESTATE INTERESTS:** List the address of any property which was involved in transactions (leasing, purchasing, or condemnation proceedings of real estate interests) with the Commonwealth or any other governmental body within the Commonwealth. If you have no direct or indirect interests in such a property, then check "NONE."
- Block 09** **CREDITORS:** List the name and address of any creditor and the interest rate of any debt over \$6,500 regardless of whether such debt is held solely by you or jointly by you and any other individual, including your spouse, where each obligor is fully responsible for the obligation. A joint obligation with other persons for which the filer is responsible only for a proportional share that is less than the reporting threshold, is not required to be reported. **Do not report a mortgage or equity loan on your home (or secondary home),** or loans or credit between you and your spouse, child, parent or sibling. Car loans, credit cards, personal loans and lines of credit must be listed on the form if the balance owed was in excess of \$6,500 at any time during the calendar year. If you do not have any reportable creditor, then check "NONE."
- Block 10** **DIRECT OR INDIRECT SOURCES OF INCOME:** List the name and address of each source of \$1,300 or more of gross income - - including but not limited to gross income from the public position - - regardless of whether such income is received solely by you or jointly by you and another individual, such as a spouse. "Income" includes any money or thing of value received or to be received as a claim on future services or in recognition of services rendered in the past, whether in the form of a payment, fee, salary, expense, allowance, forbearance, forgiveness, interest, dividend, royalty, rent, capital gain, reward, severance payment, proceeds from the sale of a financial interest in a corporation, professional corporation, partnership or other entity resulting from termination/withdrawal therefrom upon assumption of public office or employment or any other form of recompense or combination thereof. The term refers to gross income and includes prize winnings and tax-exempt income but does not include gifts, governmentally-mandated payments or benefits, retirement, pension or annuity payments funded totally by contributions of the public official or employee, or miscellaneous incidental income of minor dependent children. Filers are not required to list income amounts. If you do not have ANY reportable source of income, then check "NONE."
- Block 11** ***GIFTS:** For each source of gifts(s) valued at \$250 or more in the aggregate, list the following information: the name and address of the source; the circumstances, including a description of each gift; and the value of the gift(s). **Do not report political contributions otherwise reportable** as required by law, gift(s) from friends or family members (the term "friend" does not include a registered lobbyist or employee of a registered lobbyist), or any commercially-reasonable loan made in the ordinary course of business. The Commission has held that a person cannot be deemed a "friend" if that person and/or a business with which that person is associated is regulated by or has contracts with the public official's governmental body. If you did not receive any reportable gift, then check "NONE."
- Block 12** ***TRANSPORTATION, LODGING OR HOSPITALITY EXPENSES:** List the name and address of each source and the amount of each payment/reimbursement by the source for transportation, lodging or hospitality that you received in connection with your public position **if the aggregate amount of such payments/reimbursements by the source exceeds \$650 for the calendar year for which you are reporting.** Do not report reimbursements made by a governmental body or by an organization/association of public officials/employees of political subdivisions that you serve in an official capacity. If you do not have any reportable expense payments/reimbursements, then check "NONE."
- Block 13** **OFFICE, DIRECTORSHIP OR EMPLOYMENT IN ANY BUSINESS ENTITY:** List the name and address of the business entity for any office that you hold (Example: President, Vice President, Secretary, Treasurer), any directorship that you hold (through service on a governing board such as a board of directors), and any employment that you have in any capacity whatsoever as to any business entity. This block focuses solely on your status as an officer, director or employee, regardless of income. If you do not have any office, directorship or employment in any business entity to report, then check "NONE."

SIXTH TUESDAY PRE-PRIMARY or PRE-ELECTION REPORTS are required to be filed *only* by candidates for statewide office, their authorized candidate committees, and any political committee or lobbyist that has made an expenditure to influence the election of a statewide candidate. In 2025, statewide offices appearing on the ballot include the following:

**JUSTICE OF THE SUPREME COURT
JUDGE OF THE SUPERIOR COURT
JUDGE OF THE COMMONWEALTH COURT**

Political committees/lobbyists that have not made an expenditure to influence the election of a candidate for the statewide offices listed above do not need to file the Sixth Tuesday Pre Primary/Election report.

SECOND FRIDAY PRE- and THIRTY DAY POST-PRIMARY or ELECTION REPORTS are required to be filed by all candidates appearing on the ballot and all political committees and lobbyists that have made expenditures to influence the election of such candidates. In 2025, offices appearing on the ballot include:

**JUSTICE OF THE SUPREME COURT
JUDGE OF THE SUPERIOR COURT
JUDGE OF THE COMMONWEALTH COURT
JUDGE OF THE COURT OF COMMON PLEAS
JUDGE OF THE MUNICIPAL COURT (PHILADELPHIA COUNTY)
ALL LOCAL/MUNICIPAL OFFICES (FILE WITH APPROPRIATE COUNTY BOARD OF ELECTIONS)**

ANNUAL REPORTS must be filed by *all* candidates, political committees and contributing lobbyists that have not filed a termination report.

****SPECIAL ELECTIONS**** - In the event of any special election, candidates and committees should contact our bureau regarding reporting requirements and filing deadlines. A separate report will need to be filed for each Special Election Cycle. Special Elections do not follow the reporting dates for Cycles 1-7. Information regarding Special Election reporting dates can be found on our [website](#).

PENALTIES - In accordance with the Campaign Finance Reporting Law, those who file required reports after the filing deadline are assessed a late filing fee of \$20 per day for the first six days that a report is late, and \$10 per day thereafter, up to a maximum penalty of \$250 for each report.

NOTARIZED COVER PAGES - The Department allows ten (10) calendar days for the notarized cover page to be received in our office before the report is marked late. In the event that the notarized cover page is not received timely, a late fee will be assessed *from the date of the report filing deadline*. The Department does not accept postmarks for the cover pages.

POLITICAL COMMITTEE TREASURERS - It is the treasurer's responsibility to file required committee reports. Keep this schedule available for reference prior to each reporting deadline. If you need a reporting form, you may print one from the Department's [website](#) or request one from the bureau. You may also file your report online. From the website, select the link to Campaign Finance and then to Online Filing for more information. Please remember that all reports must include your filer identification number on the cover page.

24 HOUR REPORTING - Section 1628 of the Campaign Expense Reporting Law, 25 P.S. § 3248, requires any candidate or political committee, authorized by a candidate and created solely for the purpose of influencing an election on behalf of that candidate, which receives any contribution or pledge of five hundred dollars (\$500) or more, or any person making an independent expenditure of five hundred dollars (\$500) or more after the final pre-election/pre-primary report has been deemed completed shall report such contribution or expenditure to the appropriate supervisor. The candidate, chairperson or treasurer of the political committee shall send the report of late contributions within twenty-four (24) hours of receipt of the contribution. The same shall apply to persons making independent expenditures. The bureau will accept the filing of *24 Hour Reports* by facsimile at 717-705-0721, via e-mail at: ra-stcampaignfinance@pa.gov or [online](#). The filing of reports by facsimile or e-mail is permitted only for *24 Hour Reports*; it is not permitted for filing other campaign finance reports. The filing of late contribution reports does not remove the obligation to also report those contributions on the appropriate post-election/post-primary expense report filing and they should also be included in a post-election report. Please contact our office for specific reporting dates for late contribution reports.
